#### 6. BOARD RESOLUTIONS

- **a.** Resolution 2024-06 Construction Bond \$1,300,000 Following brief discussion, approved with no changes. Ms. Napoles moved, Ms. Conner seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- **b.** Resolution 2004-07 Construction Bond \$675,000 Following brief discussion,

approved with no changes. Ms. Napoles moved, Ms. Conner seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

#### 7. ITEMS TO BE TRANSACTED AND/OR DISCUSSED

- a. Approval of Contract for School Construction. The board and the contractor discussed the contract:
  - i. Covid precautions agreed contract language should state that contractor will follow current guidelines
  - ii. Timeline The board pointed out that the consequences for the school with delays on the reroof would be much worse than delays on the new building.
  - iii. Contract Cancellation If the district cancels the contract, the contractor wants 100% of their fees, not the whole project costs.
  - iv. The board agreed that Mr. Gross and the contractor would meet and incorporate these changes, and create a final draft. The board will meet again at a special meeting at 3:45 p.m. on Monday, December 4, to approve the final contract.
  - v. Contract with Cumming for Project Management (moved from consent agenda) A project manager serves as a foreman of the job, except that they work for the district, not the contractor. This guy has been to Pacific School a couple of times. Because we are small school, they have written their contract with language along the lines of "not to exceed \$93,000". But they don't think it will come close to \$93,000. The board agreed with the importance of bringing experts in to the process. Approved with no changes. Ms. Napoles moved, Ms. Conner seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- b. Chronic Absenteeism Mr. Gross presented a chart of chronic absenteeism at Pacific compared to Santa Cruz City Schools and the state as a whole. The board discussed ways to address it. Mr. Gross is willing to take families to SARB if necessary.
- c. CAASPP Scores Mr. Gross presented information about our CAASPP scores. Overall, our scores went up last spring compared to the previous spring. In ELA and math we had the third highest scores in the county, and in science we had the second highest scores. However, the report cards this year show that a lot of our students, especially younger students, are struggling academically.
