- a. Enrollment Lottery Ms. Chyna Darby randomized the students in the lottery (only grades K and 5 were necessary) while sharing her screen for the board to view.
- b. Construction Projects update
 - i. Outdoor classroom in Life Lab Garden -
 - 1. Ben Riordan is getting started mid-March.
 - 2. Working with UCSC professors and students to implement rainwater capture associated with the new garden classroom
 - ii. The whole crew (construction, architect, and project managers) meets weekly and has drafted a schedule:
 - 1. Roof & bathrooms during summer and before school starts
 - 2. Preschool classroom by "spring"
- c. Preschool
 - i. Admissions Priority Approved with one typo fixed. Mr. Rhabyt moved, Ms. Napoles seconded. 2 in favor, 0 opposed, 0 abstentions, 1 absence
 - ii. Tuition Rates No change for 2024-25. Approved all items. Mr. Rhabyt moved, Ms. Napoles seconded. 2 in favor, 0 opposed, 0 abstentions, 1 absence.
- d. Calendar for 2024-25 School Year Approved as presented. Ms. Napoles moved, Ms. Conner seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- e. Board Calendar for 2024-25 School Year Added a second May meeting and removed the second August meeting. Approved as modified. Ms. Napoles moved, Ms. Conner seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- f. Payroll Calendars Ms. Andrews presented reasons to move all employees to 11-month payroll calendars. The main reasons are 1. Avoid end of year payroll docks that need to be collected from employees, and 2. Simplify payroll processing in the summer months. Following discussion, the board approved making this change effective for the 2024-25 school year. Ms. Napoles moved, Ms. Conner seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
