Board Meeting Minutes

1. OPENING PROCEDURES FOR OPEN SESSION

- a. Call to Order 4:03 p.m.
- b. Roll Call & Establishment of Quorum
 - i. Gwyan Rhabyt, Board President Present
 - ii. Cari Napoles, Board Vice President Present
 - iii. Diana Conner, Board Trustee Arrived late
- c. Approval of the agenda Approved with no changes. Mr. Rhabyt moved, Ms. Napoles seconded. 2 in favor, 0 opposed, 0 abstentions, 1 absence.
 - i. Agenda deletions, additions, or changes of sequence

2. DISCUSSION – SECOND INTERIM BUDGET

- a. Second Interim Budget Michelle Kennedy, Fiscal Analyst from the COE, presented about the budget.
 - i. We budgeted 0% cola for all three years
 - ii. Bonds are presumed to have passed, which will help avoid significant costs in fund 1
 - iii. Enrollment is staying strong which is very helpful, especially with the three year rolling average.
 - iv. We may not have the physical space to continue to grow, nor might we be able to continue to attract so many students from other districts
 - v. 1-time cafeteria money is helpful, has a lot of strings attached, and deadline. We may be able to reduce the contribution from unrestricted to the cafeteria. However, like other state funds, this money could disappear.
 - vi. Prop 28 money not the same as the Art & Music block grant. Prop 28 for 23-24 = \$22,782.
 - vii. Donations received from Marin Community Foundations.
 - viii. SpEd funding increased slightly, expenses were about the same.
 - ix. Overall, we are not deficit funding, which is great. Most districts locally and around the state are deficit spending. High reserves are helpful, because they allow you to weather recessions, and other unexpected expenses. One risk is a special ed placement.

 - i. Scheduled 3/12/24, but cancelled.

- a. Discontinue Offering Home Studies Program
 - i. Reduction in service: lay off .35 FTE Home Studies Teacher
 - 1. Currently no one enrolled
 - 2. 5 have expressed interest, but no paperwork turned in
 - 3. No longer economically viable recommend that we discontinue the program

Approved discontinuation of the home study program and resolution to reduce service with no changes. Mr. Rhabyt moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.

7. ADDITIONAL ITEMS TO BE TRANSACTED AND/OR DISCUSSED

- a. Construction Projects update
 - 1. Schedule: roof & bathrooms to be completed 8/9/24
 - a. 8/12 is 1st scheduled meeting, 8/14 is 1st day of school
 - 2. Schedule: preschool to be completed 11/15 (probably a more optimistic but less crucial deadline)
 - 3. Construction has begun for the outdoor classroom in the garden, one of the crew members is a former Pacific student
- b. 2022-2023 Audit
 - i. Findings:
 - 1. SARC School Accountability Report Card:
 - a. Form had previous year on Document Tracking Services, which we weren't able to change
 - b. SARC said one teacher had wrong credential but Williams said 0 complaints. Auditor wants Williams form done incorrectly
 - 2. Safety Plan: board approved 3/21, but was due on 3/1
 - 3. Attendance: calculation overclaimed ADA by 2 = \$22,300 should be offset by correcting an underclaim
 - ii. For 2023-24, we will have a new auditor
 - iii. The board accepted the 2022-23 audit report. Mr. Rhabyt moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absence
- c. 2024-25 Work Calendars Approved with no changes. Mr. Rhabyt moved, Ms. Napoles seconded. 3 in favor, 0 opposed, 0 abstentions, 0 absences.
- d. Superintendent/Board Staff Feedback Survey Results The board discussed the feedback from the staff regarding the Superintendent and Board.
