- c. Construction Projects
 - i. Sierra West Estimates 1 year ago
 - 1. Roof & Bathrooms: \$631,212
 - 2. Preschool/TK: \$1,459,246
 - ii. Current estimates, after value engineering to reduce costs as much as possible:
 - 1. Roof & Bathrooms: \$1,130,375 This cost breakdown includes the re-roof of the admin building, renovating the girls and boy's bathrooms, along with tearing down the shed as shown in the plans and specifications. The roofing specification has been changed from Garland to Carlisle. Carlisle will provide a 25-year warranty instead of the 30-year warranty from Garland however the savings is over \$200k.
 - 2. Preschool/TK: \$1,870,708
 - iii. Following extensive discussion of various options, the board voted to move forward with the roof/bathroom project this summer as described in the narrative, and request more information about various cost-saving options (including modular or portable buildings) for the Preschool/TK. This will result in the Preschool/TK project being postponed by at least one year. Approved as described. 2 in favor, 0 opposed, 0 abstentions, 1 absence.
